Personnel

- ▶ 94 U.S. marshals, one for each federal court district
- ▶ 3,780 authorized deputy U.S. marshals and criminal investigators
- ▶ 1,666 authorized administrative employees and detention enforcement officers
- ▶ 5,540 authorized total employees (does not include the 60 Presidentially appointed U.S. Marshals)
- ▶ 94 districts, 198 sub-offices, four foreign field offices

Budget

- ▶ FY 2025: \$1.692 billion (Salaries and Expenses)
- ▶ FY 2025: \$2.2 billion (Federal Prisoner Detention)
